These Terms and Conditions ("T&C's") form a legally binding agreement between **Picaboo Studio** ("we", "us", "the Company") and the **Client** ("you"). By proceeding with a booking and making payment, you agree to be bound by these terms.

Picaboo Studio reserves the right to update or amend these Terms and Conditions at any time. Reasonable notice will be provided where changes affect existing bookings.

General

These Terms and Conditions constitute the entire agreement between the Client and Picaboo Studio. No variation or waiver shall be valid unless agreed to in writing.

This agreement shall be governed by and construed in accordance with the **laws of New Zealand**, and any disputes shall be subject to New Zealand jurisdiction.

Acceptance

A confirmed booking and/or payment signifies that you have read, understood, and accepted these Terms and Conditions in full. No variations will be recognised unless agreed to in writing by Picaboo Studio prior to the event.

Booking & Payment

- A minimum booking of 2 hours (\$300) is required for all Picabooth bookings.
 - The first 2 hours are non-refundable under all circumstances.
 - Additional hours may be booked in advance via the website and are subject to availability.
 - Additional hours booked in advance are refundable only if cancelled more than 48 hours prior to the event start time.
 - If additional time is requested during the event and we are able to accommodate this, it will be invoiced after the event.
 - All prices are in New Zealand Dollars (NZD). Picabooth Studio reserves the right to update pricing at any time.

Cancellation & Rescheduling

- A minimum of 48 hours' notice is required for cancellations or rescheduling.
 - The first 2 booked hours remain non-refundable.
 - Rescheduling is subject to availability and current pricing at the time of rebooking.

Setup & Pack-Down

Picabooth requires 1 hour for setup and 30 minutes for pack-down.

- Setup and pack-down time are not included in the booked booth operating time.
 - The Client is responsible for ensuring the venue allows sufficient access time before and after the event.

Client Responsibilities

The Client agrees to:

- Provide accurate and truthful information via the required Client Intake Form
- Ensure suitable space, safe access, and a reliable power supply at the venue
- Be responsible for guest behaviour while using the Picabooth

Picabooth Studio is not responsible for reduced service caused by incorrect or incomplete information provided by the Client.

Props, Equipment & Damage

All Picabooth equipment, props, and backdrops remain the property of Picaboo Studio.

Any loss or damage caused by misuse, negligence, or inappropriate behaviour may be charged to the Client.

Printing

Standard Picabooth bookings include 1 printed photo per session.

Additional printing may be requested at \$30 per hour and will be invoiced separately after the event.

Liability

Picaboo Studio is not liable for injuries, loss, or damage to personal property resulting from use of the Picabooth.

In the unlikely event of technical failure, loss of images prior to delivery, or circumstances beyond our control (including illness, equipment failure, or force majeure events), liability is limited to a refund of monies paid for the affected service.

Picaboo Studio is not responsible for the services or actions of third-party vendors.

Images & Usage

All images captured by the Picabooth remain the copyright of Picaboo Studio.

Unless otherwise agreed in writing, the Client grants Picaboo Studio permission to use images for portfolio, website, and marketing purposes. Requests to opt out must be made in writing prior to the event.
